

READ CAREFULLY & SIGN - MINOR WAIVER AND RELEASE OF LIABILITY

I hereby grant permission for my child(ren) _____
To participate in river tubing &/or biking at Hunt Valley Village, LLC on (date)_____

And I hereby agree as follows:

I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards and such exists in my child(ren)'s use of Hunt Valley Village, LLC's equipment and my child(ren)'s participation in Hunt Valley Village, LLC's activities; (b) my child(ren)'s participation in such activities and/or use of such equipment may result in injury or illness including but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, family members, friends, volunteers, employees, officers or agents of Hunt Valley Village, LLC; the negligence of participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge terrain, weather, trail or river route location, and water level, risks of falling out of or drowning while in a river tube and such risks, hazards and dangers that are integral to recreational activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/ or damages, weather caused in whole or in part by the negligence or other conduct of the owners, agents, officers, family, friends, volunteers or employees of Hunt Valley Village, LLC, or by any other person.

I, on the behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Hunt Valley Village, LLC and its owners, family members, friends, volunteers, agents, officers, or employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Hunt Valley Village, LLC's equipment or my child(ren)'s participation in Hunt Valley Village, LLC's activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers, family members, friends, volunteers or employees of Hunt Valley Village, LLC. I understand and agree that a personal floatation device (PFD) is required to be used by my child(ren) during all river tube activities. I understand that my child(ren) when river tubing has been provided with the *River Tubing Adventure Map* and must abide by the established protocols.

The Venue of any dispute that may arise out of this agreement or otherwise between the parties to which Hunt Valley Village, LLC or its owners, family members, friends, volunteers, agents, officers, or employees is a party shall be either the County of Baltimore, Maryland's Justice Court or the County or State Supreme Court in Baltimore County.

My child is in good health and is at or above the minimum age stated by Hunt Valley Village, LLC for each activity in which he/she will participate. I understand that strenuous physical exertion may be required and my child has no known physical disabilities or health problems, which will present any risk to his/her participation in the activities. I release and agree to indemnify and hold harmless the Releasees from any and all liabilities incident to my minor child's involvement or participation in these programs as provided above, **EVEN ARISING FROM NEGLIGENCE OF RELEASEES**, to the fullest extent permitted by law. I permit the use of any slides, films, or sketches of him/her taken during the day's activities for publicity, advertising, promotion or other commercial purpose. The above shall be binding on my heirs, successors, assigns, administrators and executors.

To the extent possible by State Law, I also freely and voluntarily waive all claims for damages or loss to my person or property of third parties, that may be caused by an act, or failure to act, of the State Forest and Park Service (SFPS) or its agents and employees, and release the SFPS and the State of Maryland from any and all claims.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE. IT IS MY INTENTION TO GRANT PERMISSION FOR MY CHILD(REN) TO PARTICIPATE IN HUNT VALLEY VILLAGE, LLC'S RIVER TUBING &/OR BIKING ACTIVITIES, AND TO ASSUME AND ACCEPT ALL RISKS ASSOCIATED THEREWITH.
