Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge terrain, weather, trail or river route location, and water level, risks of falling out of or drowning while in a river tube and such risks, hazards and dangers that are integral to recreational activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/ or damages, weather caused in whole or in part by the negligence or other conduct of the owners, agents, officers, family, friends, volunteers or employees of Hunt Valley Village, LLC, or by any other person.

I, on the behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Hunt Valley Village, LLC and its owners, family members, friends, volunteers, agents, officers, or employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Hunt Valley Village, LLC's equipment or my participation in Hunt Valley Village, LLC's activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers, family members, friends, volunteers or employees of Hunt Valley Village, LLC.
